## **MISSION**

The mission of the Monmouth Park Charity Fund is to raise and distribute funds to non-profit agencies in Monmouth County, New Jersey that provide services for those in need of healthcare, those at risk in the community and those in need of special services.

## **HISTORY**

Monmouth Park Charity Fund, Inc. (MPCF) is a community-based 501(c)(3) nonprofit organization governed by its volunteer Board of Trustees. Its rich history dates back to 1946 when a group led by the late President of the Monmouth Park Jockey Club, Amory L. Haskell of Middletown, spearheaded the revival of Monmouth Park Racetrack.

Mr. Haskell, with his partner the late Philip H. Iselin, Treasurer, invited 15 friends and acquaintances to brainstorm a strategy to thank the residents of Monmouth County for making their dream of the revival of the Monmouth Park Racetrack a reality. The result was to establish a non-profit entity that would raise funds to be distributed to area human service organizations as their way to give back to their community.

On July 21, 1947 MPCF signed their official incorporation documents and became a 501(C)(3) non-profit organization. This fundraising committee, known as the "Charity Ball Ladies," successfully held the first Charity Ball and Carnival at the Racetrack in 1947. The initial charitable grants were distributed shortly after. The same year that MPCF was incorporated. Hence, and the "giving back to Monmouth County" tradition began, and continues to this day.

The New Jersey Sports and Exposition Authority purchased the Monmouth Park Jockey Club in 1986 and honored its tradition by providing office space for MPCF to support its fundraising activities.

Today MPCF, through the support of its Board of Trustees, volunteers and donors, raises the majority of its funds through events. Its signature event, the Kentucky Derby Day Celebration, is a tribute to those who established the non-profit organization and those who keep the tradition of "giving back" alive today.

MPCF reached a major milestone in 2021. Since its incorporation in 1947, MPCF has raised and distributed over \$10 million to Monmouth County non-profit agencies to assist those in need.

## **GRANT PROGRAMS**

## TRADITIONAL LEGACY GRANTS

The ability to fundraise in 2021 was extremely challenging as COVID-19 continued to plague and impact

our communities. The MPCF Board of Trustees, its supporters and volunteers were determined to raise money to provide critically needed grants to local non-profit organizations as they faced surges of those in need of services.

The 74th Annual Roberta O. Fox Agency Distribution of Funds Tea was held in-person at the Turf Club at Monmouth Park Racetrack on November 18, 2021. MPCF and all the participants were thrilled to gather together to celebrate the grant recipients and the support they provide for those who continue to struggle in our county.

Staying true to its legacy, MPCF distributed its *Traditional Legacy Grants* to 17 local non-profit organizations in 2021, awarding \$63,500 in total. This was a 24 percent increase from 2020, even though MPCF had to once again cancel its signature fundraising event — the Kentucky Derby Day Celebration.

## ACCOMPLISH MORE TOGETHER GRANTS

In Partnership with New Jersey Natural Gas



MPCF and New Jersey Natural Gas embarked on a partnership in 2018 to offer \$5,000 competitive grants to agencies that collaborate on a program or project that is innovative and builds on each agency's strengths to increase service capacity.

The Accomplish More Together Grant program is a unique funding opportunity that invites agencies, who provide services to residents of Monmouth County, to work together on service projects to collaborate and partner to find new solutions to challenges to expand services for those in need. To date, eleven *Accomplish More Together Grants* have been awarded totalling \$55,000.

The two 2021 Accomplish More Together Grant recipients received \$5,000 for their innovative partnership programs:

## 180 Turning Lives Around & The ARC of Monmouth

180 Turning Lives Around is developing and administering a domestic and sexual violence educational curriculum for clients and staff members of The ARC of Monmouth. This curriculum will be delivered in the form of virtual presentations and include supporting materials which will also be available digitally.

The presentations and materials will be tailored specifically for the intellectually and developmentally disabled as this population is at high risk of being abused and violated. The curriculum will also be pertinent for the staff who serve them.

## Jewish Family and Children's Services of Monmouth County & From Jersey With Love

This project will expand upon a collaboration that was formed during the COVID-19 pandemic between Jewish Family and Children's Services (JF&CS) its sister food pantries, "Nourish Asbury" and "Let's Eat." This partnership will streamline JF&CS' comprehensive food programs to include ancillary services such as clothing, job readiness training, as well as information and referral services.

This collaboration will bridge the gap between the residents of Asbury Park neighborhoods and agency service providers.

## WINNERS CIRCLE SOCIETY

WINNERS CIRCLE SOCIETY

The Winners Circle Society (WCS) serves as the sustaining foundation of the MPCF mission while influencing creative funding pathways to meet the changing needs of Monmouth County residents. Members of the WCS are individual donors who make an annual contribution.

The dollars raised through the WCS are split into two revenue streams - half of the funds raised are allocated to sustain MPCF and the other half are allocated to provide a *Transformational Grant* to a local agency. WCS members participate in determining who receives the annual Transformational Grant.

MPCF presented its 2021 WCS Transformational Grant in the amount of \$21,500 to the Riding High Farm, Handicapped High Riders Club, during the Awards Reception Ceremony at its inaugural MPCF Golf Invitational, held at Suneagles Golf Club in Eatontown on September 20.

Riding High Farm, incorporated as the Handicapped High Riders Club, Inc., is a 10.5 acre farm, indoor riding facility and stable. Its mission is to maintain the highest standards of care, safety and instructional benefits for special needs riding. The organization is committed to provide these riders with recreational and therapeutic instruction.

The *Transformational Grant* dollars will fund required facility and equipment upgrades to assure that the arena is safe for all riders, as well as transform Riding High Farm's ability to increase service capacity for

special needs riders.

In addition, Riding High Farm extends programs to the community providing individual therapeutic riding and group lessons to school districts that require physical education for special needs students. Inclusivity and the integration of able-bodied riders with special needs riders in Riding High's summer camp programs provide an opportunity for key social skills development.

MPCF received 23 grant applicants and the WCS members selected three finalists who presented their agencies at an outdoor reception at the home of President Maureen Lloyd. In addition to the awardee, 180 Turning Lives Around and Interfaith Neighbors were finalists and each received a \$1,000 grant from OceanFirst Bank.
